## **Minutes of the Executive Committee, Board of Trustees and Election Committee Meetings Minutes**

### Election Issues:

Br Haroon opened the meeting after the roll call by asking election Committee for their suggestions on proceeding with the elections and any other matter relating to the elections. The Executive Committee also requested the Board of Trustee to conduct the election.

Br. Javed proposed few options:

- 1- We should continue with the existing executive committee and work on the constitution and then proceed with the elections.
- 2- We could look for an outside third party to conduct our election, but this will incur an additional expense to MCPBC.
- 3- We should follow through with Br.Haroon's request for the Board of Trustee to conduct the election.

Br. Farooq, Br. Rehmat Elahi, and Br. Subhan also proposed to have the election done by the board of trustees members due to the circumstances.

Finally, Due to the current situation of our election process being delayed for this long and many members demanding the election to take place everyone agreed to accommodate

election as soon as possible for the sake of the MCPBC and thinking of MCPBC best interest following amendments to the current constitution:

Article 7: Election was voted and approved by all members of the Trust and Executive committee members who were present at the meeting:

1-The extension of 2009 membership beyond June 2010 until further notice.

2-Article 7 Section (2) Nomination request will be announced on the Friday (Jumah) prayer and posted on the web site and given allow 10 days to submit the nomination form and within 7 days will be allowed for Nomination acceptance/withdrawal

3-Section (3) voting member of MCPBC for a minimum of two years preceding the election year will be waived.

4-Section(6) it was agreed to continue and complete the election even if it goes thru month of Ramadan.

5-It was agreed that nomination form will be available at the masjid as well on MCPBC web site and due to time limitation it will not be mailed.

Upon completion of election process Board of Trustees responsibility as election Committee will ceased and they still remain as Board of Trustees of MCPBC, Inc

All these were was voted and approved by the Executive Committee and the Board of MCPBC present.

In conclusion, the Board has agreed to conduct the elections and they will announce this on Friday, May 28, 2010 and will follow up with the schedule of the elections.
